

Utah School District School Board Highlights

August 10, 2010 business meeting

Superintendent's Report: Superintendent Dockins talked about NWEA data file which was recently received. The NWEA data file that shows that the laser like focus on math in grades kindergarten through fifth grade paid off.

Business Administrator's Report: Randy Upton updated the Board on the remodeling progress at Davis Elementary, and the construction progress of Ashley Elementary. An open house is scheduled for Eagle View Elementary September 8th at 6:00 p.m.

Award of Bid for Athletic Facility: A motion was made by Allen Huber to accept Angus Construction as the contractor for the Athletic Facility, and approve \$810,000 as the budget for the project. Teera Young seconded the motion. Those in favor: Teera Young, Allen Huber, JoAnn Cowan, and Perry Taylor. Those opposed: Dr. Rodney Anderson; motion carried.

Award of Bid for School Foods Warehouse Addition: A motion was made by Allen Huber to award the School Foods Warehouse addition to Angus Construction, with a budget of \$375,000. Teera Young seconded the motion; motion carried unanimously.

Award of Bid for Vernal Middle School Fields: A motion was made by JoAnn Cowan to award the Vernal Middle School fields to Kenny Sing construction, with a budget of \$825,800. Allen Huber seconded the motion; motion carried unanimously.

Award of Vernal Middle School Irrigation Line: A motion was made by JoAnn Cowan to award the bid to BHI to install an irrigation line to Vernal Middle School. The budget amount is \$82,000. Teera Young seconded the motion; motion carried unanimously.

Approval of Policy 010.0600 Acceptable Use Policy for Computer Use and Network Access: A motion was made by Allen Huber to approve Policy 010.0600 as presented on first and second reading. Dr. Rodney Anderson seconded the motion; motion carried unanimously.

Superintendent's Contract Review: A motion was made by Allen Huber to approve the extension and changes to the contract for Mark Dockins, Superintendent of Schools. Teera Young seconded the motion; motion carried unanimously.
