May 11, 2022 (Wednesday) - Budget adoption advertised in local paper for May Public Hearing on May 25 and Final Budget Adoption on June 15.

May 25, 2022 (Wednesday) - Public Budget Hearing - Notice

June 1, 2022 (Wednesday) - The final budget will be available for public review at Business Administrator's office

June 15, 2022 (Wednesday) – Final Budget Adoption. If the approved tax rate exceeds the certified tax rate, a truth in taxation hearing would be necessary in August.
